Avoid late payments and save time with our convenient bank draft option.

- With bank draft, you will continue to receive an electric bill each month. On your bill's due date, we will send a draft to the account listed for the amount of your bill.
- Bank Draft options are offered to all members who have a checking or savings account with a financial entity that is a member of the Automated Clearinghouse Association.
- After submitting your draft authorization, please allow time for processing. You will need to continue payment of your electric bill by other means until you begin receiving a Gibson Electric bill stating **"TO BE PAID BY DRAFT."**
- Complete the Draft Authorization form below, attach a voided check from your financial institution, then mail or deliver to your nearest Gibson Electric Member Service Center for processing. Members may also fill out the draft authorization form online at [www.gibsoncoops.com](http://www.gibsoncoops.com), print, sign and return it with a voided check to your nearest Gibson Electric Member Service Center, or mail to P.O. Box 47, Trenton, TN 38382.
