Energizing opportunity

We energize opportunities by providing reliable infrastructure and broadband access, attracting industries and helping recruit and retain jobs to build healthier communities and brighter futures.

In 2024, Gibson Electric improved the strength and reliability of electric service with upgrades to substations, our core fiber network and our internal computing platform.

We recently upgraded our infrastructure by updating the

power transformers at our Polk substation. This allowed us to relocate and add second power transformers at our Ridgely and Pierce substations. With redundant transformers now in place at every substation, we've significantly increased service reliability.

We upgraded and diversified our internal computing system by installing servers at multiple locations for enhanced redundancy. This ensures uninterrupted service, even if one server goes offline, so we can continue delivering the reliable

service you expect.

We are in the process of improving our core fiber network from 100 Gig to 400 Gig, allowing us to continue to grow and meet members' bandwidth needs while strengthening our internal system. We have received a grant covering 70% of the cost of this project.

Energizing connection

We energize connections by delivering high-speed internet, bridging the digital divide in our rural communities, empowering communication and improving access to education, healthcare and economic opportunities.

Gibson Connect celebrated significant milestones in 2024. We received +90 on a Net Promoter Score (NPS) survey, which put us in the "World Class" category for customer service. NPS measures customer satisfaction, loyalty and enthusiasm on a scale of -100 to +100.

Our NPS score indicates that Gibson Connect subscribers are satisfied with our services and inclined to advocate for us within their networks. Your positive word-of-mouth helps us expand our reach and serve more people in our communities. With your help, we celebrated service to 20,000 subscribers in 2024. Thank you for supporting Gibson Connect and for recommending us to your friends, family and neighbors!

Through Gibson Protect, we give you easy-to-use tools to help you keep your home network secure and your family safe. Gibson Protect blocks intrusions, web threats, viruses and malware and helps you manage screen time, content and access through the Gibson Connect Smart Home app. In 2024, Gibson Protect blocked a total of 2,640,994 threats. All subscribers receive these services at no additional cost.

Looking ahead, we remain committed to expanding broadband access and

providing our subscribers and communities with the tools they need to stay connected. Gibson Connect has received a grant to bring residential internet service to Bradford, and we are exploring additional opportunities beyond our service area. Growing our subscriber base helps keep rates low for everyone.

Energizing unity

We energize unity by fostering strong partnerships, supporting local initiatives and encouraging collaboration to create a stronger, more connected region.

One of the core principles of cooperatives is collaboration among co-ops. In May 2024, we received aid from several neighboring electric co-ops after a damaging windstorm caused power outages scattered across our 12-county service area. In October, eight Gibson Electric lineworkers traveled to Millen, Georgia, to help restore power after Hurricane Helene devastated the area.

Nearly 700 rural electric co-ops collaborate to improve safety for employees across the nation by participating in the Rural Electric Safety Achievement Program (RESAP). Gibson Electric completed the RESAP audit, which is done every three years, in 2024, as part of our ongoing effort to consistently engrain strong safety practices into everyday work.

With the completion of our rebranding initiative, Gibson Electric and Gibson Connect are unified with co-branding, with our gibsoncoops.com website and with our Gibson Co-ops app. We are pleased with the positive feedback we have received from our members who are happy to have all the information they need to manage their electric and broadband accounts in one place. It also makes it easier for prospective members to sign up for services and learn more about our cooperatives.

Energizing compassion

We energize compassion by giving back to our communities, extending kindness and fostering a culture of care that makes a meaningful difference in people's lives.

Supporting the communities we serve is at the heart of our mission to enhance our members' quality of life. In 2024, we partnered with CoBank and TVA to award \$109,000 in matching grant funding to nonprofit organizations. With TVA, we awarded an additional \$23,000 in economic development funding.

Our nonprofit grant recipients will use the money to support youth, empower women and children, provide disaster relief and purchase equipment to improve volunteer rescue squads. Economic development funding will be used to upgrade facilities, improve parks and support industry growth. Our members show compassion and generosity through Change for the Community, a voluntary round-up program that allows you to round up your electric bill to the nearest dollar. A Change for the Community board made up of Gibson Electric members chooses how to distribute the money to local nonprofits, with 100% of the funds staying in the service area where they are raised.

In 2024, our Kentucky members gave \$5,000 in Change for the Community grants, bringing the total since 2013 to \$168,000. Tennessee members now have the option to sign up for Change for the Community, and we are eager to donate our first round of grants in the Volunteer State. Energizing our youth

We energize our youth by providing educational initiatives and promoting energy efficiency programs that inspire smart, sustainable choices for the future.

In 2024, seven juniors from our area high schools in Tennessee and Kentucky earned the expenses-paid trip to Washington, D.C., by entering a short story contest. Each year, contest winners are also eligible for college scholarships and may choose to participate in the Youth Leadership Council.

Gibson Electric sponsors four students annually to participate in Kentucky's Frankfort Youth Tour and Tennessee's Youth Leadership Summit.

Gibson Electric also works with local schools to encourage their participation in TVA's School Uplift and STEM Classroom

Gibson Electric and Gibson Connect work with our local schools and chambers of commerce to expose students to careers available in our electric and broadband cooperatives, ensuring the next generation of our workforce can find meaningful work right here at home. Our employees are always willing to visit our local schools to promote electrical and cyber safety, show students tools of the electric and broadband

trades and read to our youngest students.




2024 Revenue Per \$1

Gibson received \$124,370,565 in revenues for the fiscal year that ended Dec. 31, 2024. Our revenues came from several sources: residential members, commercial and industrial members, miscellaneous income, lighting and broadband.



2024 Expenses Per \$1

Gibson Electric buys power from the Tennessee Valley Authority. In the fiscal year that ended Dec. 31, 2024, we spent 71% of our electric sales revenue to pay our TVA power bill. The other 29% was used for operations, maintenance, depreciation, interest and tax expenses.

Ad Valorem and Property Tax Payments

Each year Gibson Electric pays ad valorem and property taxes to the towns and counties in which the cooperative has infrastructure. The amount of taxes paid is based on the assessed value of the infrastructure, including buildings, substations, transformers, poles and lines. As we have built out our high-speed fiber network to provide internet, phone and TV services, the taxes we have paid to our communities have increased by about 60% since 2017. The 2024 ad valorem and property taxes accrued are outlined below.
